WHEREAS, Rahmans Elementary Teacher Education Institution, Priston Compound, Hanumakonda Road, Jangaon - 506167, Warangal District, Andhra Pradesh was granted recognition to D.EI.Ed course of two years duration with an annual intake of 50 students on 01.08.2005 with condition that the institution shall shift to its own premises within three years from the date of recognition(in case the course is started in rented premises)..

AND WHEREAS, on 25.03.2015, a letter dated 16.03.2015 was received from the Director of School Education, Telangana, Hyderabad regarding grant of renewal of temporary provisional affiliation for the year 2014-2015 in respect of certain private Diploma in Elementary Teacher Education institutions

AND WHEREAS, the SRC in its 289th meeting held on 23rd June, 2015 considered the letter dated 16.03.2015 from Director of School Education, Govt. of Telangana, Hyderabad, in respect of certain private Diploma in Elementary Teacher Education (43 colleges) not fulfilling the deficiencies and decided to issue show cause notice for the following ground:

### • 1 + 5 approved staff list is submitted.

AND WHEREAS, show cause notice was issued to the institution on 16.09.2015. The institution submitted its reply on 28.10.2015.

AND WHEREAS, the SRC in its 293<sup>rd</sup> meeting held on 29<sup>th</sup> - 31<sup>st</sup> October, 2015 considered the show cause notice reply and decided the "staff list is proper. Close the case".

AND WHEREAS, a letter was sent to the Director, SCERT on 10.11.2015.

AND WHEREAS, the institution submitted its written representation on 18.02.2016 along with some relevant documents which was placed before SRC in its 304th meeting held on 19th to 20th February 2016, the committee considered the matter and decided as follows;

- Shifting fees difference to be paid.
- After receiving of shifting fees the application to be considered.

AND WHEREAS, the institution submitted its written representation on 23.02.2016 along with shifting fee and approved staff list.

AND WHEREAS, the SRC in its 305th meeting held on 25th - 27th February, 2016 considered the shifting case and decided to "Cause inspection for shifting. Inform SCERT and University for admissions".

AND WHEREAS, the inspection intimation was sent to the institution and VT members on 16.03.2016. The inspection of the institution was conducted on 20.03.2016. The VT report received

AND WHEREAS, the SRC in its 302<sup>nd</sup> Meeting held on 09<sup>th</sup>-11<sup>th</sup> February, 2016 considered the letter from the Director School Education Department, Telangana State and decided that "What with the 3rd March 16 time-limit pressure on us, it is not possible to go into these complaints at this time. Process and put up after March 16".

AND WHEREAS, the SRC in its 308th meeting held on 28th - 30th March, 2016 considered the VT report and decided as "shifting permitted".

**AND WHEREAS,** shifting order was issued to the institution for both B.Ed & D.El.Ed courses on 01.06.2016.

AND WHEREAS, again as per the decision of SRC, the matter was placed before SRC in its 309<sup>th</sup> Meeting held on 12<sup>th</sup>-14<sup>th</sup> April, 2016 and the committee considered in respect of (76 colleges) regarding not fulfilling the deficiencies and decided to issue show cause notice for the following ground:

. Shifting of college premises without the permission of SRC-NCTE.

**AND WHEREAS,** as per the decision of SRC, show cause notice was issued on 13.05.2016. The institution submitted show cause notice reply along with relevant documents on 04.07.2016.

**AND WHEREAS**, the SRC in its 318<sup>th</sup> meeting held on 08<sup>th</sup> & 09<sup>th</sup> August, 2016 considered the matter and decided to issue Formal Recognition for D.El.Ed (1 unit) at the new site.

NOW THEREFORE, this order is issued granting recognition to the institution Rahmans Elementary Teacher Education Institution, H.No.3-13, Yeshwanthpura Village, Jangaon Mandal, Warangal District – 506175, Telangana for running D.El.Ed course of two years duration with an intake of 50 students from the academic session 2016-17 subject to fulfillment of the following conditions:

- The Endowment fund of Rs.5 lakhs and Reserve fund of Rs.7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014, as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 2. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University / Body, the State Government etc, as applicable.
- 3. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant
- 4. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter –alia, the details of the institution, its location, name of the programme with intake; availability of physical infrastructure, such as land, building, office, classrooms, and other facilities or amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
  - a. Sanctioned programmes along with annual intake in the institution:
  - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c. Name of faculty members who left or joined during the last, quarter:
  - Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
  - e. Fee charged from students;
  - f. Available infrastructural facilities;
  - g. Facilities added during the last quarter;
  - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;

i. The affidavit with enclosure submitted along with application.

j. The institution shall be free to post additional relevant information, if it so desires.

- Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- The institution shall adhere to the mandatory disclosure in the prescribed format and display upto-date information on its official website.
- 6. The institution shall make available the list of students admitted on its official website.
- 7. The institution shall fill the information on GIS Portal on the NCTE website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued thereunder, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisions of Section17(1) of the NCTE Act, 1993.

Also order that a copy of this order be published in the official Gazette.
